## Data privacy statement

We would like to provide you with detailed information on how your personal data may be used and/or stored in connection with your registration to compete in the German Long Drive Championship. All personal data shall be handled in strict conformity with the provisions of Germany's Datenschutz-Grundverordnung (General Data Protection Regulation, DSGVO) and Bundesdatenschutzgesetz (Federal Data Protection Act, BDSG). This data privacy statement is designed to advise you of the manner, extent, and purposes in and for which personal data may be collected or handled by us. Also included is information about your own personal rights.

## Personal data

Generally considered to be personal data are: given name, surname, date of birth, gender, email address, handicap, name of home golf club, status, starting times, player group, driving distance, data provided voluntarily in player profiles (which will be sent to competitors at a later date).

## Purposes for which personal data and photographic material may be used

Personal data shall be processed, stored, and used for the following purposes:

- *Status, telephone number, account details*  
Your status will be published in starting and registration lists as well as used within our communication (e.g. on our GLDC-website, social media posts, newsletters).  
Your telephone number will not be published or disclosed under no circumstances. Your telephone number is required only in the events that there may be any queries relating to your registration. Your account details and address are used solely for debiting the handling fee from your account after receipt of the registration form.

## Legal basis for use of data

Your personal data is required for the organization and management of the events, i.e. to fulfil the demands of the contractual relationship existing between us. Serving as legal basis for this are the provisions of Title 6, Section 1 b) of the DSGVO data protection regulation (see above).

## Your rights

You may, at any time, request information on the personal data relating to you held by us and, where necessary, ask for this to be amended or rectified.

You also have the right, pursuant to the provisions of Title 6, Section 1, Letter e or f of the DSGVO, to file an objection to the manner in which personal data is handled or stored.

In the events of cases as set forth under Title 7 DSGVO, you may also request that your data be deleted. In any events, however, your data will be deleted once it is no longer required for contractual processing requirements, or for any other legally prescribed purposes. In the events that you consider the handling and processing of your personal data to violates existing data privacy provisions, please feel free to contact us about this.
